

WEAK AND EXACT DOMINATION IN DISTRIBUTED SYSTEMS

In this work, we introduce and examine the notion of domination for a class of linear distributed systems. This consists in studying the possibility to make a comparison between input or output operators. We give the main algebraic properties of such relations, as well as characterizations of exact and weak domination. We also study the case of actuators, and various situations are examined. Applications and illustrative examples are also given. By duality, we extend this study to observed systems. We obtain similar results and properties, and the case of sensors is equally examined.

Keywords: distributed systems, domination, actuators, sensors.

1. Introduction

Controllability and observability are two dual notions which are very important in systems theory and where the choice of input and output operators plays a major role. In this area, the literature is very rich. Characterization results on the notions of weak and exact controllability and observability, as well as strategic actuators and sensors, are established (Afifi and El Jai, 1994; 1995; Afifi *et al.*, 2002a; 2002b; 2008a; Berrahmoune, 1984; Curtain and Pritchard, 1978; Curtain and Zwart, 1995; El Jai and Pritchard, 1987; Jacob and Zwart, 2001; Lions, 1968; 1988; Qarai *et al.*, 2008; Uciński and Korbicz, 1990; Zerrik, 1993; Zerrik *et al.*, 2007). But in almost all these works, the problems considered are focused on the possibility to reach a desired state or reconstruct the state of the examined system, i.e., on studying if a system is (or not) controllable or observable, but without comparison between the input or output parameters themselves.

This work concerns control and observation operator domination for a class of distributed systems. It can be considered as a natural extension of previous works on the notions of controllability and observability.

We consider, without loss of generality, a linear distributed system described by the following state equation:

$$(S) \begin{cases} \dot{z}(t) = Az(t) + Bu(t), \\ z(0) = z_0, \end{cases} \quad (1)$$

where A generates a strongly continuous semi-group (s.c.s.g.) $(S(t))_{t \geq 0}$, $B \in \mathcal{L}(U, Z)$, U and Z are respectively the control and state (Hilbert) spaces.

The system (1) is augmented by the following output equation:

$$y(t) = Cz(t), \quad (2)$$

where $C \in \mathcal{L}(Z, Y)$, Y is the observation space (a Hilbert space). The state $z(t)$ of the system at time t is given by

$$z(t) = S(t)z_0 + H_t(B)u, \quad (3)$$

where

$$H_t(B)u = \int_0^t S(t-s)Bu(s) ds$$

and the observation by

$$y(t) = CS(t)z_0 + CH_t(B)u. \quad (4)$$

For the controlled system (1), we study the behavior of the reached space $\text{Im}(H_T(B))$ with respect to the operator B and the possibility of comparing input operators or actuators.

Concerning observed systems, similar relations are introduced for the output operators or sensors.

This work is organized as follows: In Section 2, we introduce and characterize the exact and weak dominations. Specific properties of these notions are presented. The case of systems excited by actuators and various situations are also examined. Then, in Section 3, we give an application to a diffusion system and illustrative examples. In the last section, we introduce similar notions for observed systems. By a duality result, we deduce, from the previous sections, analogous results and properties.

Let us note that, with a convenient choice of control and observation spaces, the obtained results can be extended to the case where the operators B and C are unbounded.

2. Case of controlled systems

2.1. Problem statement and definitions. We consider the following linear distributed systems:

$$(S_1) \begin{cases} \dot{z}_1(t) = Az_1(t) + B_1u_1(t), & 0 < t < T, \\ z_1(0) = z_{1,0} \in Z, \end{cases} \quad (5)$$

$$(S_2) \begin{cases} \dot{z}_2(t) = Az_2(t) + B_2u_2(t), & 0 < t < T, \\ z_2(0) = z_{2,0} \in Z, \end{cases} \quad (6)$$

where A is a linear operator generating a strongly continuous semi-group $(S(t))_{t \geq 0}$ on the state space Z , $B_1 \in \mathcal{L}(U_1, Z)$, $B_2 \in \mathcal{L}(U_2, Z)$, $u_1 \in L^2(0, T; U_1)$ and $u_2 \in L^2(0, T; U_2)$; U_1 and U_2 are two control spaces (Hilbert spaces).

Without loss of generality, one can assume that $z_{1,0} = z_{2,0} = z_0$. In this case, the states of the systems (S_1) and (S_2) at the final time T are respectively given by

$$z_1(T) = S(T)z_0 + H_1u_1, \quad (7)$$

$$z_2(T) = S(T)z_0 + H_2u_2, \quad (8)$$

where H_1 and H_2 are the operators defined by

$$H_1 : \begin{cases} L^2(0, T; U_1) & \longrightarrow & Z, \\ u_1 & \longrightarrow & \int_0^T S(T-s)B_1u_1(s) ds, \end{cases} \quad (9)$$

and

$$H_2 : \begin{cases} L^2(0, T; U_2) & \longrightarrow & Z, \\ u_2 & \longrightarrow & \int_0^T S(T-s)B_2u_2(s) ds. \end{cases} \quad (10)$$

Definition 1.

1. We say that the system (S_1) dominates (S_2) (or that B_1 dominates B_2) exactly on $[0, T]$, if $\text{Im}(H_2) \subset \text{Im}(H_1)$.
2. We say that the system (S_1) dominates (S_2) (or that B_1 dominates B_2) weakly on $[0, T]$, if $\overline{\text{Im}H_2} \subset \overline{\text{Im}H_1}$.

In these situations, we write, respectively, $(S_2) \leq (S_1)$ (or $B_2 \leq B_1$) and $(S_2) \preceq (S_1)$ (or $B_2 \preceq B_1$).

Remark 1.

1. Let us note that the relation of exact or weak domination for systems having the same dynamics A is transitive, reflexive but not symmetric, nor antisymmetric. Hence, for example, for any operator $B \neq 0$, we have $\text{Im}B = \text{Im}(2B)$, even if $B \neq 2B$.

However, in exact as well as weak cases, one can define equivalence relations (and hence equivalence classes) respectively as follows:

$$B_1 \mathcal{R}_{ex} B_2 \iff \text{Im}(H_1) = \text{Im}(H_2)$$

and

$$B_1 \mathcal{R}_{we} B_2 \iff \overline{\text{Im}(H_1)} = \overline{\text{Im}(H_2)}.$$

2. Exact domination implies weak one. The converse is not true (this will be shown later).

3. In the case where (S_1) is exactly (respectively, weakly) controllable on $[0, T]$, i.e., $\text{Im}H_1 = Z$ (resp. $\overline{\text{Im}H_1} = Z$), then for any operator B_2 , the system (S_2) is dominated exactly (resp. weakly) by (S_1) .

4. In fact, one can also consider a single system (S) with two inputs as follows:

$$(S) \begin{cases} \dot{z}(t) = Az(t) + B_1u_1(t) + B_2u_2(t), & 0 < t < T, \\ z(0) = z_0. \end{cases} \quad (11)$$

In this case, domination concerns only the control operators B_1 and B_2 . The definitions and all the results remain practically the same.

5. In this work, we consider systems with the same dynamics A , but the obtained results can be extended easily to the case where the systems (S_1) and (S_2) have respectively dynamics A_1 and A_2 , generating, on the state space Z , strongly continuous semi-groups $(S_1(t))_{t \geq 0}$ and $(S_2(t))_{t \geq 0}$.

2.2. Characterizations. We have the following characterization result concerning the exact domination.

Proposition 1. *The following properties are equivalent:*

- (a) The system (S_1) dominates (S_2) exactly on $[0, T]$.
- (b) For any $u_2 \in L^2(0, T; U_2)$, there exists a control $u_1 \in L^2(0, T; U_1)$ such that

$$H_1u_1 + H_2u_2 = 0.$$

- (c) There exists $\gamma > 0$ such that, for any $\theta \in Z$, we have

$$\|B_2^*S^*(T - \cdot)\theta\|_{L^2(0, T; U_2)} \leq \gamma \|B_1^*S^*(T - \cdot)\theta\|_{L^2(0, T; U_1)}. \quad (12)$$

Proof. It follows from the definition and from the fact that, if X, Y and Z are reflexive Banach spaces, $P \in \mathcal{L}(X, Z)$ and $Q \in \mathcal{L}(Y, Z)$, then (Curtain and Pritchard, 1978)

$$\text{Im}(P) \subset \text{Im}(Q)$$

if and only if there exists $\gamma > 0$ such that, for any $z^* \in Z'$, we have

$$\|P^* z^*\|_{X'} \leq \gamma \|Q^* z^*\|_{Y'}.$$

■

We give hereafter a characterization of weak (or approximate) domination.

Proposition 2. (S_1) dominates (S_2) weakly, if and only if

$$\ker(B_1^* S_1^*(\cdot)) \subset \ker(B_2^* S_2^*(\cdot))$$

Proof. It results from the definition and the fact that $\overline{\text{Im}H_2} \subset \overline{\text{Im}H_1}$ if and only if $\ker(H_1)^* \subset \ker(H_2)^*$. ■

2.3. Case of actuators. In what follows, we assume that $Z = L^2(\Omega)$ and that A is self-adjoint and has a complete orthonormal system of eigenfunctions $\{\varphi_{nj}, j = 1, \dots, r_n; n \in \mathbb{N}^*\}$ associated with the real eigenvalues $(\lambda_n)_{n \geq 1}$ such that $\lambda_1 > \lambda_2 > \lambda_3 > \dots$, where r_n is the multiplicity of λ_n . In this case,

$$Az = \sum_{n=1}^{+\infty} \lambda_n \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \varphi_{nj} \quad (13)$$

and the s.c.s.g. $(S(t))_{t \geq 0}$ generated by A is given by

$$S(t)z = \sum_{n=1}^{+\infty} e^{\lambda_n t} \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \varphi_{nj}. \quad (14)$$

In the case where (S_1) is excited by p zone actuators $(\Omega_i, g_i)_{1 \leq i \leq p}$, we have $U_1 = \mathbb{R}^p$ and (Berrahmoune, 1984; El Jai and Pritchard, 1987)

$$B_1 : \begin{cases} \mathbb{R}^p & \longrightarrow & L^2(\Omega), \\ \alpha & \longrightarrow & B\alpha = \sum_{i=1}^p \alpha_i g_i, \end{cases} \quad (15)$$

where $\alpha = (\alpha_1, \dots, \alpha_p)^{\text{tr}} \in \mathbb{R}^p$ and $g_i \in L^2(\Omega)$; $\Omega_i = \text{supp}(g_i) \subset \Omega$. We have

$$B_1^* z = (\langle g_1, z \rangle, \dots, \langle g_p, z \rangle)^{\text{tr}}.$$

Analogously, if (S_2) is excited by q zone actuators $(D_i, h_i)_{1 \leq i \leq q}$, we have $U_1 = \mathbb{R}^q$ and

$$B_2 : \begin{cases} \mathbb{R}^q & \longrightarrow & L^2(\Omega), \\ \beta & \longrightarrow & B_2 \beta = \sum_{i=1}^q \beta_i g_i, \end{cases} \quad (16)$$

with $\beta = (\beta_1, \dots, \beta_q)^{\text{tr}} \in \mathbb{R}^q$, $h_i \in L^2(\Omega)$, $D_i = \text{supp}(h_i) \subset \Omega$ and

$$B_2^* z = (\langle h_1, z \rangle, \dots, \langle h_q, z \rangle)^{\text{tr}}.$$

We have the following characterization of the exact domination, resulting from Proposition 1.

Proposition 3. *The system (S_1) dominates (S_2) exactly if and only if there exists $\gamma > 0$ such that, for any $z \in Z = L^2(\Omega)$, we have*

$$\begin{aligned} & \left\| \left(\sum_{n=1}^{+\infty} e^{\lambda_n t} \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \langle h_i, \varphi_{nj} \rangle \right)_{1 \leq i \leq q} \right\|_{L^2(0, T; \mathbb{R}^q)} \\ & \leq \gamma \left\| \left(\sum_{n=1}^{+\infty} e^{\lambda_n t} \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \langle g_i, \varphi_{nj} \rangle \right)_{1 \leq i \leq p} \right\|_{L^2(0, T; \mathbb{R}^p)}. \end{aligned} \quad (17)$$

We give hereafter a necessary condition concerning exact domination.

Proposition 4. *If the system (S_1) dominates (S_2) exactly, then there exists a real $\gamma > 0$ such that, for any $n \in \mathbb{N}^*$ and $j \in \{1, \dots, r_n\}$, we have*

$$\|(\langle h_i, \varphi_{nj} \rangle)_{1 \leq i \leq q}\|_{\mathbb{R}^q} \leq \gamma \|(\langle g_i, \varphi_{nj} \rangle)_{1 \leq i \leq p}\|_{\mathbb{R}^p}. \quad (18)$$

Proof. Using the previous proposition, if (S_1) dominates (S_2) exactly, then there exists $\gamma > 0$ satisfying the inequality (17) for any $z \in Z$. For $z = \varphi_{nj}$ in this inequality, we obtain

$$\begin{aligned} & \|e^{\lambda_n t} (\langle h_i, \varphi_{nj} \rangle)_{1 \leq i \leq q}\|_{L^2(0, T; \mathbb{R}^q)} \\ & \leq \gamma \| (e^{\lambda_n t} \langle g_i, \varphi_{nj} \rangle)_{1 \leq i \leq p} \|_{L^2(0, T; \mathbb{R}^p)} \end{aligned}$$

or, equivalently,

$$\begin{aligned} & \|e^{\lambda_n t}\|_{L^2(0, T; \mathbb{R})} \|(\langle h_i, \varphi_{nj} \rangle)_{1 \leq i \leq q}\|_{\mathbb{R}^q} \\ & \leq \gamma \|e^{\lambda_n t}\|_{L^2(0, T; \mathbb{R})} \|(\langle g_i, \varphi_{nj} \rangle)_{1 \leq i \leq p}\|_{\mathbb{R}^p}. \end{aligned}$$

Since $\|e^{\lambda_n t}\|_{L^2(0, T; \mathbb{R})} > 0$, we have

$$\|(\langle h_i, \varphi_{nj} \rangle)_{1 \leq i \leq q}\|_{\mathbb{R}^q} \leq \gamma \|(\langle g_i, \varphi_{nj} \rangle)_{1 \leq i \leq p}\|_{\mathbb{R}^p}.$$

■

An immediate consequence of Proposition 4 is that if

$$\langle g_i, \varphi_{n_0 j} \rangle = 0, \quad 1 \leq i \leq p$$

for some $n_0 \in \mathbb{N}^*$ and $j \in \{1, \dots, r_{n_0}\}$, then

$$\langle h_i, \varphi_{n_0 j} \rangle = 0, \quad 1 \leq i \leq q.$$

In some situations, this can be used to show that (or to reconstruct) a system (which) is not dominated exactly by another one. Concerning weak domination, we give the following definition.

Definition 2. If $B_2 \preceq B_1$, we say that $(D_i, g_i)_{1 \leq i \leq p}$ are more strategic than $(\Omega_j, h_j)_{1 \leq j \leq q}$.

Now, let us show the following result, which leads to matrix characterization of weak domination.

Lemma 1. We have

$$\ker B_1^* S^*(\cdot) = \{z \in Z \mid (\langle z, \varphi_{nj} \rangle)_{j=1, r_n} \in \ker M_n, \forall n \geq 1\},$$

where M_n is the controllability matrix defined by

$$M_n = (\langle g_i, \varphi_{nj} \rangle)_{1 \leq i \leq p; 1 \leq j \leq r_n}. \tag{19}$$

Proof. We have

$$B_1^* S^*(t)z = \left(\sum_{n=1}^{+\infty} e^{\lambda_n t} \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \langle g_i, \varphi_{nj} \rangle \right)_{1 \leq i \leq p}. \tag{20}$$

Then $z \in \ker B_1^* S^*(\cdot)$ if and only if

$$\sum_{n=1}^{+\infty} e^{\lambda_n t} \sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \langle g_i, \varphi_{nj} \rangle = 0, \quad \forall i \in \{1, \dots, n\}. \tag{21}$$

Using the analyticity property, this is equivalent to

$$\sum_{j=1}^{r_n} \langle z, \varphi_{nj} \rangle \langle g_i, \varphi_{nj} \rangle = 0, \quad \forall n \geq 1, \forall i \in \{1, \dots, p\},$$

i.e.,

$$\forall n \in \mathbb{N}^*, (\langle z, \varphi_{nj} \rangle)_{1 \leq j \leq r_n} \in \ker M_n. \quad \blacksquare$$

It is well known that the actuators $(D_i, g_i)_{1 \leq i \leq p}$ are strategic (i.e., the corresponding system (S_1) is weakly controllable) if and only if

$$\text{rank}(M_n) = r_n, \quad \forall n \geq 1.$$

We have the same results concerning (S_2) by replacing M_n with the matrix G_n defined by

$$G_n = (\langle h_i, \varphi_{nj} \rangle)_{1 \leq i \leq q; 1 \leq j \leq r_n}. \tag{22}$$

The following proposition gives a necessary and sufficient condition for weak domination.

Proposition 5. The system (S_1) dominates (S_2) weakly if and only if

$$\ker M_n \subset \ker G_n, \quad \forall n \in \mathbb{N}^*.$$

Proof. Assume that $\ker M_n \subset \ker G_n$, for any $n \in \mathbb{N}^*$.

Using Lemma 1, we have

$$\begin{aligned} z &\in \ker B_1^* S^*(\cdot) \\ &\Leftrightarrow \forall n \in \mathbb{N}^*, (\langle z, \varphi_{nj} \rangle)_{j=1, r_n} \in \ker M_n \\ &\Rightarrow \forall n \in \mathbb{N}^*, (\langle z, \varphi_{nj} \rangle)_{j=1, r_n} \in \ker G_n \\ &\Rightarrow z \in \ker(B_2^* S^*(\cdot)). \end{aligned}$$

Conversely, if

$$\exists m \in \mathbb{N}^* \text{ such that } \ker M_m \not\subset \ker G_m,$$

then there exist $(\alpha_{mj})_{1 \leq j \leq r_m} \in \mathbb{R}^{r_m}$ which satisfy $(\alpha_{mj})_{1 \leq j \leq r_m} \in \ker M_m \setminus \ker G_m$. For

$$z = \sum_{j=1}^{r_m} \alpha_{mj} \varphi_{mj}, \tag{23}$$

we have

$$B_1^* S^*(t)z = (e^{\lambda_m t} \sum_{j=1}^{r_m} \alpha_{nj} \langle g_i, \varphi_{mj} \rangle)_{1 \leq i \leq p} = 0_{\mathbb{R}^p}$$

and

$$B_2^* S^*(t)z = (e^{\lambda_m t} \sum_{j=1}^{r_m} \alpha_{nj} \langle h_i, \varphi_{mj} \rangle)_{1 \leq i \leq q} \neq 0_{\mathbb{R}^q}.$$

Consequently,

$$\ker(B_1^* S^*(\cdot)) \not\subset \ker(B_2^* S^*(\cdot)). \quad \blacksquare$$

The above result is a practical tool to study weak domination and then to make a comparison between actuators using Definition 2. Now, we give hereafter other specific properties and characteristics concerning the notions of weak and exact domination.

Proposition 6.

(P1) There exist operators B_1 and B_2 such that any one of them do not dominate the other.

(P2) An actuator (\overline{D}, h) may be dominated weakly by a non strategic actuator (D, g) .

(P3) An actuator (D, g) may dominate another actuator (\overline{D}, h) weakly, but not exactly.

(P4) A system excited by p actuators (with $p > 1$) may be dominated exactly or weakly by another system excited by one actuator (and hence by q actuators with $q < p$).

These properties and situations are illustrated in the following section.

3. Application to a diffusion system and illustrative examples

We consider, without loss of generality, the one-dimensional case where $\Omega =]0, a[$ and where the systems (S_1) and (S_2) are respectively described by the following equations:

$$(S_1) \begin{cases} \frac{\partial z_1}{\partial t}(x, t) = \frac{\partial^2 z_1}{\partial x^2}(x, t) \\ \quad + g(x)u(t), \quad \Omega \times]0, T[, \\ z_1(0, t) = z_1(a, t) = 0, \quad]0, T[, \\ z_1(x, 0) = 0, \quad]0, a[, \end{cases} \quad (24)$$

and

$$(S_2) \begin{cases} \frac{\partial z_2}{\partial t}(x, t) = \frac{\partial^2 z_2}{\partial x^2}(x, t) \\ \quad + h(x)v(t), \quad \Omega \times]0, T[, \\ z_2(0, t) = z_2(a, t) = 0, \quad]0, T[, \\ z_2(x, 0) = 0, \quad]0, a[. \end{cases} \quad (25)$$

In this case, we have $Z = L^2(\Omega)$ and $Az = \Delta z$ for $z \in D(A) = H^2(\Omega) \cap H_0^1(\Omega)$. A yields a complete system of eigenfunctions $(\varphi_n)_{n \in \mathbb{N}^*}$ associated with the eigenvalues

$$\lambda_n = -\frac{n^2 \pi^2}{a^2}$$

with

$$\varphi_n(x) = \sqrt{\frac{2}{a}} \sin \frac{n\pi x}{a}.$$

First, let us recall that an actuator (Ω, g) is strategic if and only if, for any $n \geq 1$, we have

$$\langle g, \varphi_n \rangle \neq 0.$$

Obviously, a strategic actuator dominates weakly any finite number of other actuators. We also note that (Ω, g) dominate (Ω, h) weakly if, and only if, for any $n \in \mathbb{N}^*$, we have

$$\langle g, \varphi_n \rangle = 0 \implies \langle h, \varphi_n \rangle = 0.$$

Property (P1) is illustrated by the following examples.

Example 1. Let $m, n \in \mathbb{N}^*$ such that $m \neq n$. We suppose that (S_1) is excited by an actuator (Ω, g) with a spatial distribution $g = \varphi_n$ and that (S_2) is excited by an actuator (Ω, h) with a spatial distribution $h = \varphi_m$. For $p = m + n$, we have

$$\langle \varphi_m, \varphi_p \rangle = \langle \varphi_n, \varphi_p \rangle = 0.$$

Then these actuators are not strategic. Moreover,

$$\langle g, \varphi_n \rangle = 1, \quad \langle g, \varphi_m \rangle = 0$$

and

$$\langle h, \varphi_n \rangle = 0, \quad \langle h, \varphi_m \rangle = 1.$$

Then any one of these actuators does not dominate the other weakly. \blacklozenge

Example 2. For $g(x) = x(a - x)$, we have

$$\langle g, \varphi_n \rangle = \int_0^a \sqrt{\frac{2}{a}} (a - x)x \sin\left(\frac{\pi x n}{a}\right) dx$$

With $t = \pi x/a$, we have

$$\langle g, \varphi_n \rangle = \sqrt{\frac{2}{a}} \left(\frac{a}{\pi}\right)^3 \int_0^\pi (\pi - t)t \sin(nt) dt.$$

Using integration by parts, we obtain

$$\begin{aligned} & \int_0^\pi P(t) \sin(nt) dt \\ &= \left[-P(t) \frac{\cos nt}{n} + P'(t) \frac{\sin nt}{n^2} P''(t) \frac{\cos nt}{n^3} \right]_0^\pi \\ & \quad - \int_0^\pi P^{(3)}(t) \frac{\cos nt}{n^3} dt. \end{aligned}$$

Then

$$\langle g, \varphi_n \rangle = \sqrt{\frac{2}{a}} \left(\frac{a}{\pi n}\right)^3 2(1 - (-1)^n).$$

For $h = 2x - a$, we have

$$\langle h, \varphi_n \rangle = \int_0^a \sqrt{\frac{2}{a}} (2x - a) \sin\left(\frac{\pi x n}{a}\right) dx.$$

We obtain, by the same token,

$$\langle h, \varphi_n \rangle = -\sqrt{\frac{2}{a}} \frac{a^2(1 + (-1)^n)}{\pi n}.$$

Then

$$\forall n \in \mathbb{N}^*, \begin{cases} \langle g, \varphi_n \rangle = 0 \iff n = 2p \ (p \geq 1), \\ \langle g, \varphi_n \rangle = 0 \iff n = 2p + 1 \ (p \geq 0). \end{cases}$$

Consequently, (Ω, g) and (Ω, h) are not strategic and any one of them does not dominate the other weakly. \blacklozenge

Now, in order to illustrate Property (P2), we consider the following situation.

Example 3. For $\bar{D} = D = \Omega$; $g = \varphi_1 + \varphi_2$ and $h = \varphi_1$, we have

$$\forall n \in \mathbb{N}^*, \langle g, \varphi_n \rangle = 0 \implies n \geq 3 \implies \langle h, \varphi_n \rangle = 0.$$

Then (Ω, g) is not strategic and (Ω, g) dominate (Ω, h) weakly. Moreover, one can also verify that (Ω, g) dominate (Ω, h) exactly. \blacklozenge

Concerning (P3), we consider the following example.

Example 4. For $\overline{D} = D = \Omega$; $g = x(x^2 - a^2)$ and $h = 2x - a$, we have

$$\langle g, \varphi_n \rangle = \int_0^a \sqrt{\frac{2}{a}} x(x^2 - a^2) \sin\left(\frac{n\pi x}{a}\right) dx.$$

For $t = \pi x/a$, we have

$$\langle g, \varphi_n \rangle = \sqrt{\frac{2}{a}} \left(\frac{a}{\pi}\right)^4 \int_0^\pi t(t^2 - \pi^2) \sin(nt) dt$$

Using integration by parts, we obtain

$$\langle g, \varphi_n \rangle = 6\sqrt{2a}(-1)^n \left(\frac{a}{n\pi}\right)^3.$$

Then (Ω, g) is strategic. To avoid such a case, we consider

$$g(x) = x(x^2 - a^2) + 6\sqrt{2a} \left(\frac{a}{\pi}\right)^3 \varphi_1(x).$$

We have

$$\langle g, \varphi_1 \rangle = 0$$

and

$$\langle g, \varphi_n \rangle = 6\sqrt{2a}(-1)^n \left(\frac{a}{\pi n}\right)^3, \quad \forall n \geq 2.$$

On the other hand,

$$\langle h, \varphi_n \rangle = -\sqrt{\frac{2}{a}} \frac{a^2(1 + (-1)^n)}{\pi n}.$$

Since, for every $n \in \mathbb{N}^*$, we have that

$$\langle g, \varphi_n \rangle = 0 \implies \langle h, \varphi_n \rangle = 0,$$

(Ω, g) dominate weakly (Ω, h) . Let us show that (Ω, g) do not dominate (Ω, h) exactly.

If (Ω, g) dominate (Ω, h) exactly, then, using Proposition 4,

$$\exists \gamma > 0 \text{ such that } |\langle h, \varphi_n \rangle| \leq \gamma |\langle g, \varphi_n \rangle|, \forall n \in \mathbb{N}^*.$$

For $n = 2p$, we obtain

$$\sqrt{\frac{2}{a}} \frac{a^2}{\pi p} \leq \gamma 6\sqrt{2a} \left(\frac{a}{2\pi p}\right)^3, \quad \forall p \in \mathbb{N}^*.$$

which is not possible. Consequently, (Ω, g) do not dominate (Ω, h) exactly. \blacklozenge

The last property is illustrated hereafter.

Example 5. It is sufficient to consider the case where B_1 is associated with the actuator $([0, a], x(x^2 - a^2))$ and B_2 is associated with the two actuators $(([0, a/2], \varphi_2)$ and $([a/2, a], \varphi_4)$). \blacklozenge

4. Case of observed systems

In this part, we extend the notion of domination established for input operators and controlled systems, to the case of output operators and observed systems. We introduce the same notion of domination for observed systems and sensors. The characterizations and results are similar to those obtained in the previous section and can be deduced by duality.

Let Z be a separable Hilbert space. We consider the system

$$(S') \begin{cases} \dot{z}(t) = Az(t), & 0 < t < T, \\ z(0) = z_0, \end{cases} \quad (26)$$

where A is a linear operator generating a strongly continuous semi-group $(S(t))_{t \geq 0}$.

The system (26) is augmented with the output equations

$$y_1(t) = C_1 z(t), \quad 0 < t < T, \quad (27)$$

$$y_2(t) = C_2 z(t), \quad 0 < t < T, \quad (28)$$

where $C_i \in \mathcal{L}(Z, Y_i), i = 1, 2$. Here Y_1 and Y_2 are Hilbert spaces (observation spaces).

The first observation is given by

$$y_1(t) = C_1 S(t) z_0, \quad 0 < t < T,$$

and the second one by

$$y_2(t) = C_2 S(t) z_0, \quad 0 < t < T.$$

For $i = 1, 2$, we have

$$y_i(\cdot) = K_i(\cdot) z_0$$

with

$$K_i = C_i S(\cdot)$$

and

$$K_i^* y = \int_0^T S^*(t) C_i^* y(t) dt.$$

We introduce the following similar definitions.

Definition 3.

(i) We say that C_1 dominates exactly C_2 on $[0, T]$, with respect to the system (S) , if

$$\text{Im} K_2 \subset \text{Im} K_1.$$

(ii) We say that C_1 dominates weakly C_2 on $[0, T]$, with respect to the system (S) , if

$$\overline{\text{Im} K_2} \subset \overline{\text{Im} K_1}.$$

In these cases, we note respectively $C_2 \leq C_1$ and $C_2 \preceq C_1$.

Let $C_i = B_i^*$; for $i = 1, 2$. We consider the dual systems

$$(S_i^*) \begin{cases} \dot{z}(t) = A^*z(t) + B_i u_i(t), & 0 < t < T, \\ z(0) = z_0, \end{cases} \quad (29)$$

and

$$(\tilde{S}_i) \begin{cases} \dot{z}(t) = A^*z(t), & 0 < t < T, \\ y_i(t) = C_i z(t). \end{cases} \quad (30)$$

For $i = 1, 2$, it is well known that the system (29) is controllable if and only if (30) is observable. From this duality between the notions of controllability and observability, one can deduce the following characterization result.

Proposition 7. *The observed system (\tilde{S}_1) dominates exactly (respectively weakly) (\tilde{S}_2) , if and only if, the controlled system (S_1^*) dominates exactly (respectively weakly) (S_2^*) .*

Using this duality, a general result concerning exact and weak domination for controlled and observed systems, we obtain similar results and properties by replacing B_i with C_i^* and H_i with K_i^* , and hence by replacing actuator(s) with sensor(s).

Finally, let us note that in this work we consider a class of linear systems, but the results and the approach considered can be extended to other systems and situations (non-linear systems, delayed systems, unbounded operators, regional case, etc.).
